Ryan also noted that further changes include downsizing of the Sport BC staff while maintaining core services (Financial Services and KidSport BC), the resignations of CEO, Tim Gayda and Director of Financial Services, Kam Loodu, as well as the resignation of board Chair, Larry Harper. Ryan acknowledged the work of Kimberly Gilhooly, who assumed the role of Operations Manager during this transition period, as well as Carey Dillen, Chair of the Finance and Audit Committee, and the other board committees, who were actively assisting the staff and work of Sport BC during this difficult time.

Finance and Audit Committee Report

Carey Dillen provided an overview of the ongoing work of the Finance and Audit committee and thanked the staff of the financial services department for their efforts. The following items were addressed:

Consolidated Financial Statements: The statements include Sport BC, SBC Insurance, KidSport BC and All Sport Insurance (50%).

2012 Audit: Dillen thanked the financial services team for their work, resulting in a “Clean Audit Opinion”. The highlights of the statements related to the lease surrender liability, deferred rent inducements and deferred lease costs, a write off of capital assets and surplus of \$19K before the adjustments noted.

2013 Budget: The 2013 budget reflects the overall balanced operations. The highlights of the budget included the surrender payment of \$250K. The budget was segregated into the major functional areas of Sport BC’s core operations, FIRSTAR sport centre, KidSport BC and SBC Insurance.

Insurance Update

Rob Newman

Rob Newman, President and CEO of SBC Insurance, provided a brief overview of his extensive experience in the insurance business, as well as the services and background of SBC and All Sport Insurance. He also addressed the challenges and recommendations made arising from the review of SBC Insurance conducted in October 2011, and some of the plans to be implemented going forward.

Facility Update

Twyla Ryan advised that as of the end of March 2013, Sport BC and all members will have vacated the BCIT facility. Ryan thanked the staff and board for effectively negotiating a one year lease extension. The board and staff will be addressing the next steps over the coming months.

Sport BC Plans for 2012 – 2013 and Beyond

BC Sport Agency

Scott Ackles

Scott Ackles, CEO of the BC Sport Agency, provided a brief backgrounder on the ongoing collaborative process which has taken place over the last few months, resulting in five strategic objectives, reviews and recommendations. The five objectives were: to simplify the sector; unify sport; build strategic partnerships; have sustainable investment; and provide advocacy to the sector.

Discussions of the recommendations are underway with MSOs. There will be a consultative process to take place with PSOs, with a survey to be distributed within the next two weeks. The agency has targeted mid-July for a presentation to the sector. Information gathering will take place in the Fall, with December 1, 2012 set for the agency to meet and discuss report findings with the PSO groups as well. Ackles noted that funding will come through the Agency's office, similar to that of the Canadian Sport for Life model.
