#### **2016 – 2017 BY THE NUMBERS**

**5,000** athletes, coaches and officials from 52 countries came to Metro Vancouver from around the world to participate in the Inaugural Americas Masters Games, hosted by Sport BC.

**7,747** young aspiring athletes from across British Columbia received support from KidSport through grants totaling more than \$1.98 million dollars.

A \$75,000 annual gift in a three-year partnership with the Westminster Savings Credit Union highlights KidSport's corporate fundraising efforts along with corporate campaigns and events sponsored by Ritchie Bros., Triple O's and Loblaws.

**\$1,669,374** dollars in donations made through the National Sport Trust Fund supported 86 projects in 30 different sports across Canada.

**18** athletes from 21 cities in British Columbia were recognized for their excellence in sport by the 450 attendees at the 51<sup>st</sup> annual Athlete of the Year Awards gala evening. Emceed by CBC's Scott Russell at the Fairmont Waterfront Hotel, attendees celebrated the best in BC's sport community.

**43** dedicated volunteers from across BC were recipients of the 23<sup>rd</sup> annual Presidents' Awards at a ceremony that preceded the Athlete of the Year Awards gala. Sponsored by *Sports with Balls*, the Awards were presented by the Honourable Peter Fassbender, Minister of Community, Sport and Cultural Development.

**29** Volunteers from the communities of Summerland, Cowichan Valley, Abbotsford and Nelson were honoured with Community Sport Hero Awards in their local communities.

This past August, BC athletes competed in two amazing sporting events – one in Rio and one in Vancouver! As fiscal 2017 came to a close, the organization rallied like a true competitor to complete the sale of the organizations 50% interest in All Sport Insurance. We look to maintain this momentum in fiscal 2018 as we continue to make progress on major initiatives that will support our membership and align with our strategic plan.

Sport BC has many people to acknowledge for our ongoing success, but we have to start by thanking all of our enthusiastic and dedicated volunteers who give so much time and energy to our provincial sport community. Volunteers are the backbone of the amateur sport system and are the driving force behind the accomplishments of BC's athletes.

On behalf of the Board of Directors, we greatly appreciate the invaluable support from the Province of British Columbia, and look forward to continuing our work with the Minister and Ministry of Community, Sport and Cultural Development. ## **Message from the President & CEO**



Sport BC had much to celebrate in 2016!

Not only did we celebrate the success of our athletes at the Rio 2016 Olympic and Paralympic Games, we continued to enhance our membership services and events and strengthen our capacity in Major Games hosting.

Sport BC was pleased to welcome three new Provincial Sport Organizations and three affiliate members last year. Our members are the heart of our organization. As such, we continue to enhance our programs and services to support the leadership and growth of amateur sport across the province. Initiatives such as KidSport continue to provide grants to an increasing number of families. The National Sport Trust Fund still leads the country in total donations. Sport BC's payroll services and employee benefits program offer an effective way for its members to outsource employer services.

In addition, SBC Insurance continues to operate as a full brokerage offering sports liability insurance, accident benefits, travel insurance, as well as a full suite of property and casualty insurance products for the sports sector and beyond. Our 50% share in All Sport Insurance was sold and an investment committee was created to manage the sale proceeds. SBC Insurance will now focus on expanding its market share in the upcoming year with new marketing and media campaigns.

Recognizing and rewarding the contributions and accomplishments of our members continues to be an important part of the Sport BC culture. In 2016, we held our annual Athlete of the Year Awards and Community Sport Hero Awards. The 51<sup>st</sup> Athlete of the Year Awards, featuring Scott Russell as Master of Ceremonies, honoured 18 recipients from across BC. Christine Sinclair, after an outstanding season with Canada Soccer's Women's National Team and the Portland Thorns FC, was named "Best of BC". The Community Sport Hero Awards, held throughout the year, honoured 29 dedicated volunteers from four communities for their contributions to amateur sport at the community level.

Hosting international sport events can bring direct and significant sport benefits to our Province. In partnership with the City of Vancouver, PavCo, Tourism Vancouver, Vancouver Hotel Destination Association, UBC, and our Provincial Sport Organizations, Sport BC hosted the inaugural Americas Masters Games in August 2016. Over 5,000 athletes, coaches and officials from between the ages of 30 and 101 years and from around the world participated in twenty-three sports. These Games established a new standard of excellence and provided a forum for the celebration of athletic and cultural excellence, providing British Columbians and the rest of Canada with the opportunity to contribute to the expression of Canadian identity.

There are many reasons for the strength of Sport BC, but the most important is the leadership and oversight of our Board of Directors and the support of our partners. Our Board members are extraordinarily generous with their time and wisdom and we thank them for bringing their passion, intellect, insight, and experience to the table. A special thank you to outgoing Director Debbie Pyne who has been a great resource, contributor and promoter. We are grateful to have worked with her.

We would also like to thank our many partners who make it possible for us to do the work that we do every day. Through their collaboration and support, we are able to build the capacity of our members and advocate on their behalf to improve the landscape for organized sport in BC.

The Athlete of the Year Awards, founded by Sport BC, is the longest-running annual sport recognition event in Canada. Awards in 18 different categories are presented each year to athletes, coaches, officials and volunteers for their contributions to sport in our province. The awards play a valuable role in nurturing athletic success and recognizing some of BC's most exciting talent. Notable past recipients include Steve Nash, Willie Mitchell, Carey Price, Christine Sinclair, Denny Morrison, Terry Fox, and Maëlle Ricker.

The 51<sup>st</sup> annual Athlete of the Year Awards recognition event was held on Wednesday, March 8, 2017 at the Fairmont Waterfront Hotel with over 450 guests in attendance including member Provincial Sport Organizations, sport sector partners and award recipients. Minister of Community, Sport and Cultural Development, the Honourable Peter Fassbender, representing the Government of British Columbia, was in attendance to personally honour the recipients.

The host of the evening was Gemini-Award winning broadcaster, acclaimed author, and CBC Sports veteran for more than 25 years, Scott Russell. Scott has hosted 11 Olympic Games, most recently, the 2016 Rio Olympics. His unparalleled enthusiasm for amateur sport made Scott the perfect host for the evening.





This year's finalists and recipients represent 18 sports and 21 cities across British Columbia. In 2017, the finalists and recipients competed in the following sports: para-athletics, para-cycling, volleyball, basketball, synchronized swimming, triathlon, curling, athletics, tennis, swimming, football, gymnastics, cycling, golf, lawn bowling, ice hockey, triathlon, lacrosse, rowing and field hockey.

The Community Sport Hero Awards recognizes coaches, officials, mentors and administrators who have dedicated themselves to amateur sport at the community level. Since its inception in 2001, over 50 Provincial Sport Organizations have honoured 536 sport volunteers in 45 different communities across BC. In the past year, KidSport gave grants totalling over \$1.9 million dollars to 7,759 young people across British Columbia. While there were challenges this year, we were able to increase the total allocation of money through the program. There was a slight decrease in the number of children assisted, in part because in some regions grants were increased to compensate for the increase in registration fees, and in part reflecting the termination of our relationship with Canadian Tire's JumpStart program. Some of our chapters have also struggled with recruiting new volunteers and this has affected their ability to generate revenue.

Soccer and hockey once again led all sports in grant allocations. Soccer received funding for 2,489 young athletes while hockey had a total of 1,224 funded young players. Gymnastics received a 17 percent increase in their assistance over last year with 795 grant recipients. The breakdown of grants by gender was 62 percent male and 38 percent female, which is roughly equivalent to the makeup of the sport sector.

We would like to thank our PSO partners at Basketball BC, BC Soccer, BC Wheelchair Sports, and BC Lacrosse for their generous support and vision in helping us to ensure a sustainable future. Special kudos to BC Soccer for their third annual donation of \$10,000 to KidSport!

The Ministry of Community, Sport and Cultural Development once again provided a significant investment in support of KidSport, which we were then able to leverage through our community chapter fundraising initiatives.

We were fortunate as well to have the support of our great corporate partners, Westminster Savings and Ritchie Bros Auctioneers along with event partners at Triple Os, Loblaws, and CIBC.

Building on our success, we will, in 2017/18, focus on strengthening our volunteer infrastructure, developing creative new partnerships (like our innovative relationship with the Vancouver Police Department) and continuing to enhance our brand awareness and revenue generation opportunities.

# **National Sport Trust Fund**


The National Sport Trust Fund (NSTF) is a philanthropic gift-giving program established through the Canadian Council of Provincial and Territorial Sport Federations (CCPTSF) for the development of amateur sport on a national level. It is a Registered Canadian Amateur Athletics Association (RCAAA) with the Canada Revenue Agency and as a registered Association is able to issue official tax receipts for all qualifying donations of \$20 or greater. The CCPTSF has provincial chapters across Canada, with Sport BC as the Fund Manager of the BC chapter.

One of the functions of the CCPTSF is to manage a national fundraising initiative for amateur sport. This permits individual Canadian sport organizations to raise funds for specific causes that will promote the development of amateur sport in Canada. Those organizations that have registered projects are responsible for both the fundraising and the expenditures related to the funds raised. Over the last few years, the CRA has accepted the uniqueness of the NSTF while, at the same time, strongly suggesting the implementation of policies, procedures and documentation to ensure ongoing compliance with CRA policies.

With sport organizations looking to diversify their revenue streams, the National Sport Trust Fund offers the opportunity for sporting groups to develop fundraising programs which target fundraising from private sources including individuals, corporations and foundations.

### Highlights:

- 86 projects in 30 different sports received donations from April 2016 March 2017;
- \$54,352 in fee revenue was generated for Sport BC;
- 1,055 donations totalling \$1,669,374 were made in the fiscal year.



# Cycling BC benefitting from the NSTF

The NSTF is an integral part of Cycling BC's continued success, particularly related to our iRide schools program and our ability to support national team athletes like Aidan Caves, and junior athletes striving to compete at national and international competition.

With the help of the NSTF, Cycling BC was able to offer support to athletes like Maggie Coles-Lyster, who came away from Switzerland with a bronze medal, and Aidan Caves who is currently riding for Canada with the Men's Track Endurance Program and competing in the World Cup circuit in Track. Equipment, travel and ongoing training costs are challenges for our young athletes. The NSTF offers us a way to help the community support these committed young people.

In 2016, the iRide schools program reached over 8,500 school-aged children. Funding that comes to Cycling BC through the NSTF helped us expand our fleet of bikes to three additional communities, and expose more kids to cycling as a sport and confidence builder.

# **Providing Services for the Sport Sector in BC**

Sport BC provides top-of-the-line services to our members at affordable rates. We offer various financial services to our members, including payroll and group benefits.

For payroll services, we provide the following:

Direct deposit into each employee's bank account;

WCB reporting and remittances;

T4 and T4A filings;

Statutory deductions and remittances.

For group benefits, we provide the following services:

Administration of comprehensive benefit package through Great West Life such as life, accidental death & dismemberment (AD&D), critical illness, employee assistance program

(EAP), short-term and long-term disability (STD and LTD) and extended health and dental;

Administration of group provincial health plan (Medical Services Plan);

Administration of group registered retirement savings plan (RRSP).

In 2016 – 2017, Sport BC provided payroll services to 60 PSOs and clubs, processing payroll over **\$1.2 million** dollars for 360 employees. We also provided services for WCB reporting and remittances for 31 PSOs.

As of March 2017, we have 50 PSOs and clubs enrolled in the GWL benefit plan, 43 PSOs and clubs in group MSP and 3 PSOs and clubs enrolled in group RRSP under TD Future Builder.

**GREAT WEST LIFE -** There are **50 PSOs/clubs** with **179** plan members

WORKSAFE BC – 31 PSOs/clubs for 187 employees



Over the last 12 months, SBC Insurance has seen an increase in brand awareness, and has had some successes. SBC was the insurance provider for the Americas Masters Games, which was noticed by many of the PSO partners. As a result, SBC has been approached to provide the insurance for other high profile events in the Province, including the International Triathlon World Championships taking place in Penticton in August 2017.

While AllSport Insurance remains our main partner, with the sale of Allsport to Markel International, we have been able to increase our market availability, and have been successful in placing several new policies with Everest and other carriers.

We continue to align ourselves with carriers that place SBC Insurance in a position to deliver new and important coverages to our clients, as well as provide SBC with the opportunity to seek out new revenue streams. We continue to leverage our existing relationships with Chubb Insurance to provide high end home insurance solutions, as well as Can-Sure and Premier Marine to provide insurance products to business clients within and outside the sport sector. Additionally, we also partnered with CAFO Insurance Premium Finance, for clients who wish to defer payments throughout the year instead of paying the full amount at the start of the policy term. Clients can now choose to pay their insurance premiums in installments.

In 2016 – 2017 SBC Insurance became a fully licensed Insurance Brokerage in Alberta and Saskatchewan, as well as all 3 territories, and we are well positioned to provide our specialized coverage and service to those regions.

Staffing changes most recently include the hiring of Perry Solkowski as an account executive. Perry brings with him over 20 years of broadcast and media experience within the sport community. His main task will be to drive new business opportunities to SBC Insurance and Sport BC. He will be reaching out to various PSO partners to develop opportunities for growth for SBC Insurance within the sport sector as well as other business sectors needing insurance coverages.

Areas of growth potential for SBC Insurance includes **CYBER-LIABILITY** coverage. With the upcoming changes in the Canadian Anti-Spam Legislation (CASL) legislation to take effect July 1, 2017, and the enforcement of the Digital Privacy Act (DPA), our PSO partners should be aware of the reporting requirements that have become mandatory. SBC Insurance has a product available through Can-Sure that will provide coverage should a PSO partner suffer a security breach and the personally identifiable information of the PSO's members be taken. The costs resulting from a security breach has are not related to the size of the organization, but rather to the size of its database.

We are excited by the opportunities ahead of us at SBC Insurance. We have the products available to provide insurance to any industry and the knowledge to service any type of commercial insurance account. From contractors, to yoga studios and everything in between, we can insure that! Our most recent non-sport success was the Course of Construction, and Wrap Up liability policy for a \$10,000,000 greenhouse project!

## **Spreading the Word of Sport**

This year, Sport BC worked hard to enhance our presence on social media and to make our voice heard in the sport community. We utilized social media outlets such as Facebook and Twitter to promote events, fundraisers, athlete's accomplishments and our partners.

Along with our social media presence, we have continued to spread news of programs, current and upcoming events within the membership, as well as job opportunities within the sport sector through our monthly electronic newsletter. Digital media, including social media, has been transformative in sharing sport news and knowledge.

As Sport BC gains more followers through social media, our influence grows. Our insight into our audience and its increased understanding of our role has been a positive force in our ability to share knowledge across sport organizations. Content is easily distributed and shared among networks.

For example, during the lead up to the 51<sup>st</sup> Annual Athlete of the Year Awards, Twitter engagement saw a 559% increase from 2016 to 2017. Tweets that were published over a 32-day period about the annual gala earned over **73k impressions!** 

On event day, March 8, 2017, @SportBC had almost **40k impressions** compared to almost 6k impressions in 2016. The top tweet, congratulating Christine Sinclair on her *Best of BC* Award in 2017 had 12,166 impressions.





### **FINANCIAL SUMMARY**

#### Revenues




This financial summary is based on the audited consolidated financial statements of Sport BC for the year ended March 31, 2017. The financial statements and accompanying notes are available on our website at SportBC.com.

Sport BC reported a consolidated net surplus of \$2,513,034 for the year ended March 31, 2016 compared to a surplus of \$262,400 for prior year. The net surplus for the year includes a gain of \$2,302,300 on the sale of Sport BC's 50% ownership interest of Allsport Insurance Marketing Ltd. Consolidated net assets were \$3,616,466 as at March 31, 2017.

In fiscal 2017 Sport BC delivered on the 2016 Americas Masters Games. The consolidated financial statements reported revenues of \$2,322,000 and expenses of \$2,322,000 with respect to the operations of the Games. As the Games were a one-time occurrence, the charts above exclude these revenues and expenses. Sport BC earned \$80,300 in fee for service income in fiscal 2017 (2016 – \$14,000) for its role in organizing the Games.

## Expenses



Revenues were \$4,193,400 for the year compared \$3,889,200 last year. Included in revenues was \$2,321,900 (\$1,497,900 last year) related to Sport BC's involvement in the 2016 Americas Masters Games and the 2015 FIFA Women's World Cub Fan Zone. Fee for service and other revenues were \$262,000 lower than last year as Sport BC did not receive cash fee income from Allsport as it had in prior years. As a result, Sport BC's equity earnings in Allsport increased \$184,600 over last year.

Revenues of SBC Insurance Agencies Ltd. were \$110,900 below last year; however, expenses were also \$91,400 lower than the previous year. After bringing the administrative functions of SBC Insurance in-house last year, fiscal 2017 was a year of rebuilding for Sport BC's wholly-owned insurance subsidiary. Management expects to see increasing revenues in the coming year.

Sport BC's consolidated operating expenses were \$4,273,300 in the year, compared to \$3,720,600 in fiscal 2016. Total expenses included \$2,321,900 for the operations of the 2016 Americas Masters Games. In fiscal 2016 expenses included \$1,497,900 for FIFA Fan Zone and the 2016 Americas Masters Games. Expenses in other Sport BC operating departments were consistent of the prior year.
