## **Larry Feagan**

Through years of service in the sport sector, I offer proven leadership in Non-Profit organizations, comprehensive understanding of good governance, and a solid foundation in business operations.

As current Chair of Triathlon BC, and an elected official for over 10 years, I routinely collaborate with the Board and the Executive Director to lead strategic decision-making, oversee the operations, engage with stakeholder relations, and volunteer management. I routinely work with the Finance Committee to develop the annual budget to ensure our continued success.

Inclusion and diversity are pillars of the organization. Under my leadership, the Board and Staff routinely engage in professional development, creating stronger relationships with LGBTQ2IS, First Nations and BIPOC communities, routinely embracing new participants to the sport.

Outside of sport, my professional career extends to over 15 years as the Sales & Operations Manager of Subaru Canada.
