## Jennifer Fenton

Jennifer is a Health, Physical Activity and Sport Education Consultant for JW Sporta. Her 30-year career has specialized in healthy school initiatives across BC. On the national level, Jennifer was instrumental in developing CAAWS' On the Move initiative and has been a facilitator for Canadian Women & Sport workshops. She currently is a Sport BC Director and was past chair for the Active North Shore Network, ProMOTION Plus, Canadian Women & Sport and Orienteering BC. She continues to enjoy co-instructing the UBC KIN 465 course on interculturalism, inclusion and health through physical activity.

As an advocate for gender equity her whole career Jennifer was recently an honoree of the ProMOTION Plus' in Her Footsteps 2018 Award as well as their President's Award. Jennifer completed her master's in Human Kinetics at UBC and is a multi-sport certified children's coach, an active mom and avid outdoor enthusiast who can be seen cycling, hiking and kayaking the North Shore and world-wide.

## Lisa Kwiatkowski
