Award Description

This award is named in honour of the late Daryl Thompson, former chair of Sport BC, whose contributions to sport as an athlete, coach and executive officer were exemplary. This award recognizes an individual who has contributed their time in an extraordinary way to sport over a long period of time and/or has made a major contribution to amateur sport in British Columbia.

Criteria

- Recognition is for contribution on a provincial, national or international scale;
- The recipient is determined by the Sport BC Board of Directors;
- Nominations are valid for three (3) years. (Each nominee who is not honoured in a particular year will automatically be considered as a nominee in the subsequent two years. Additional material will be accepted to update the application);
- Nominations are only to be submitted by Sport BC member organizations.

Submission Requirements

- Fully completed nomination packages <u>must include</u>, and not exceed 5 pages total:
 - Completed nomination form
 - Four (4) photos of the nominee (headshot/action) in high-definition quality in .jpeg format.
 - Supporting documentation is highly encouraged (ie: news articles, etc.)
