3. Opening remarks

JUDY JOSEPH-BLACK

- General discussion about Future of Sport Commission highlighting the key concept of the work to date being a move toward a more aligned sport systems possibly with one single entity organization.
- Positive that Sport BC had representation in September meeting.

- Judy provided overview of November Board retreat, highlighting the opportunity to come together and map out a roadmap for Sport BC.











4. President and CEO Report

ROB NEWMAN

- Rob presented highlights from the President and CEO report including:
 - Advocacy work on behalf of members and the overall sector continues, most of the work is done with the direction of the Advocacy Work Group
 - Sport BC was approached by member organization the BC Sports Hall of Fame to become an operational partner for the organization. The BCSHF is in the process of coming through some challenges and are seeking operational support. This is the first step to bring the concept of the ask to the Board for feedback, next will be to have a framework and more details from the BCSHF to be explored more during the November 20 retreat. Reminder that this would only be a one-year pilot and not a long-term agreement.
 - o Planning for the inaugural Sport Event Exchange BC 2025 (November 21) is well underway and Board are invited to register for the day. The event website with more details is now live and can be accesses here.

5. Finance Committee Report

- Judy shared the Finance Committee recently met to review the material in the President & CEO report; overall no concerns and reminder that Sport BC Insurance is a key driver for Sport BC revenue and SBCI is strong.
- Rob shared that Budget approved by the previous board is the first approved deficit budget which is a reflection of the program growth and increasing staff capacity to keep up with demand and work on key growth areas for the organization and membership support.

- Brian shared that the Governance Committee met with Toa Consulting to review work to date, provide feedback and confirm the process moving forward
- Noted that presentation prior to the Board meeting ensured the Board is up to date, reminder this work was undertaken to be a road map for the organization to be leading with best practices, not because of a crisis
